- Compile the minutes into a report.

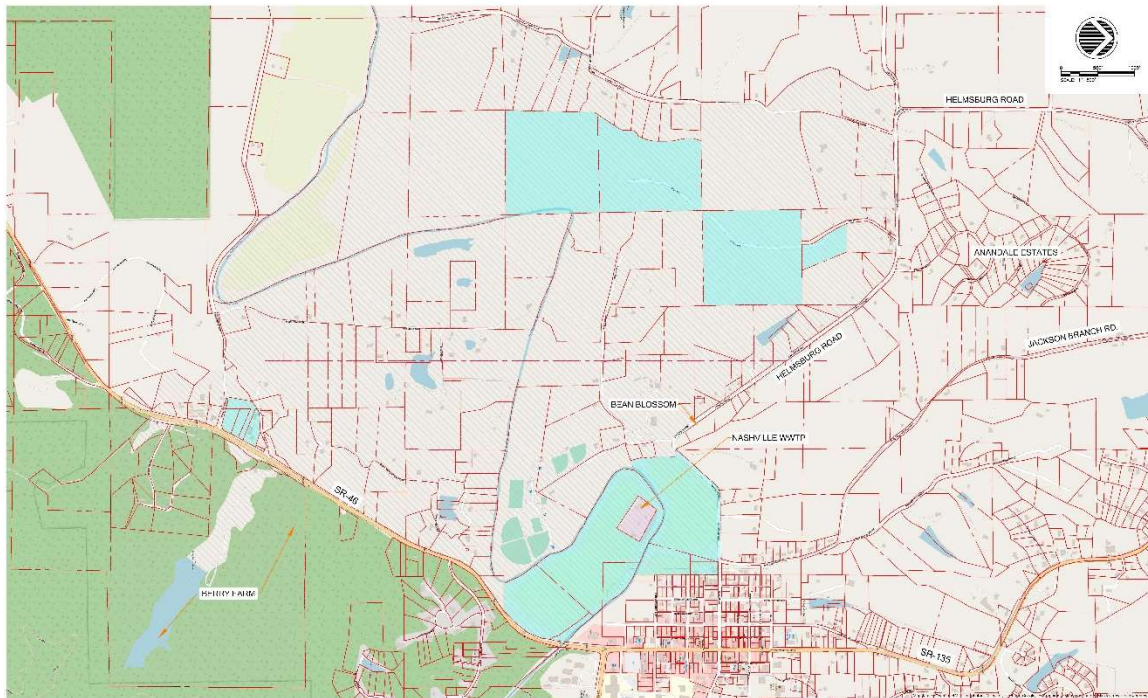

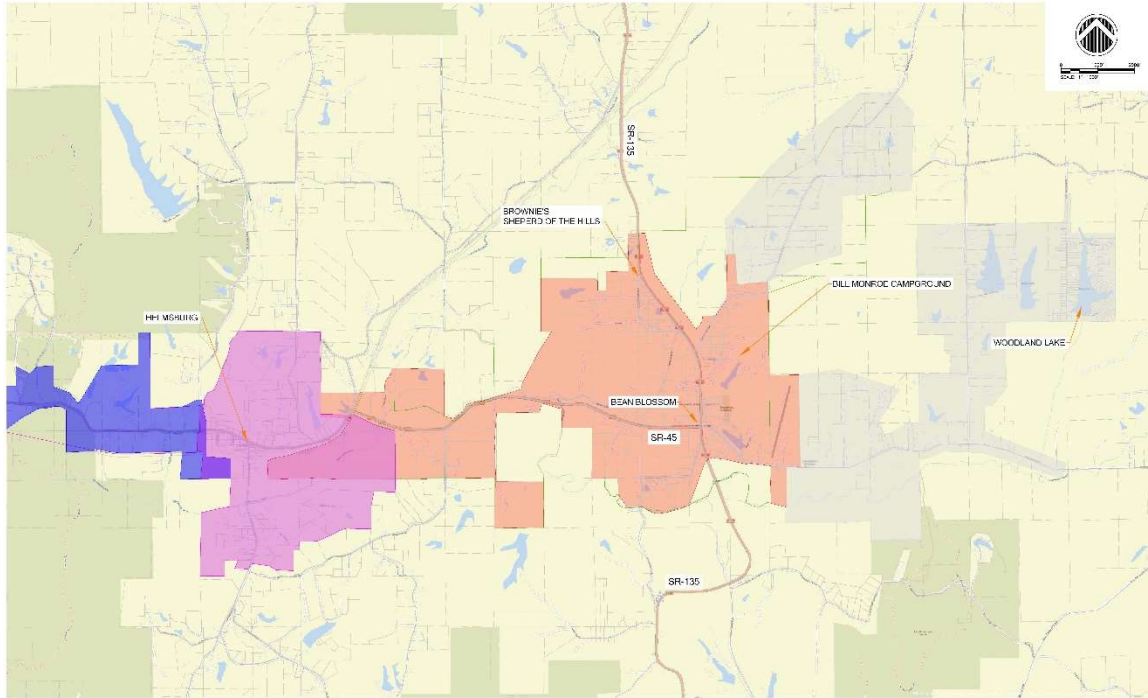
