**AN ORDINANCE OF THE BOARD OF
COMMISSIONERS OF BROWN COUNTY,
INDIANA ADOPTING A LOGGING PERMIT
APPLICATION AND LOGGER IDENTIFICATION
CARD**

WHEREAS, people come to Brown County, Indiana, to perform logging; and

WHEREAS, logging is the cutting, skidding, on-site processing, and loading of trees or logs onto trucks; and

WHEREAS, logging is a dangerous occupation where loggers deal with heavy, moving weights and the use of tools such as chainsaws and heavy equipment on uneven and sometimes steep or unstable terrain; and

WHEREAS, loggers deal with severe environmental conditions, such as inclement weather and severe heat or cold and are often far from emergency treatment; and

WHEREAS, by logging permit and logger identification card, the County will be more effective and efficient in its Police, Fire, and Building code enforcement endeavors; and


WHEREAS, pursuant to Indiana Code § 36-1-3, the County Commissioner (the "Commissioners") of the Brown County, Indiana (the "County"), has the authority and responsibility to provide for the public health and welfare of all its residents.


NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF BROWN COUNTY AS FOLLOWS:


1. A Logging Permit Application and Logger Identification Card, as provided in Exhibit A attached hereto and incorporated by reference, is hereby declared necessary for any logging (cutting, skidding, on-site processing, and loading of trees onto trucks) activities.
2. The Fee for such logging Permit Application and Logger Identification Card will be \$25.00, which must be renewed annually.
3. This ordinance shall be effective upon adoption.




ORDINANCE NO. 12/9/13/30

AN ORDINANCE TO AMEND THE BROWN COUNTY, INDIANA ORDINANCE REGULATING
LOGGING PERMITS AND LOGGER IDENTIFICATION CARDS

WHEREAS, the Commissioners passed Ordinance No. 4/3/13/08 on 4/3/13, regulating logging in Brown County to include procedures for obtaining permits and identification cards; and

WHEREAS, the Commissioners desire to add a fine structure for violations of said ordinance; and

WHEREAS the Commissioners have taken all necessary and legal steps for amendment of said ordinance;

NOW THEREFORE, BE IT ORDAINED by the Board of Commissioners of Brown County as follows:

Section 1. The following additional section is added to Ordinance No. 12/9/13/30

4. Anyone found to be in violation of this Ordinance shall be fined by the County as follows:
 - a. First Offense - \$500.00
 - b. Second Offense - \$1000.00
 - c. Third Offense – Loss of license for a period of time to be determined by the County Commissioners after a hearing and opportunity to be heard.
